SPGA July Golf Challenge 2018

1. Dates

- a) Three (3) Days Championship event will be held on Wednesday 11th to Friday 13th July 2018 (3day 2nights)

2. Venue

- a) PalmSpring Golf & Country Club (Palm & Resort course)
- b) Staying at Batam View Hotel & Resort

3. Eligibility

- a) Entries are open to SPGA Professionals & Amateurs with USGA Handicap Index 8.0 & below, as at 30th June 2018

4. Entries

- a) All entries must be completed with the Travel **information and advance entry fee payment**, and subject for approval by SPGA Executive Committee which reserves the right to accept or refuse, or having accepted, subsequently rejects any entry without giving reason for its decision. (Late entry not accepted).

5. Format

- a) This SPGA Golf Challenges 2018 shall be decided by stroke play over 54-holes, in accordance with the Rules of Golf as approved by the R&A Rules Limited and with the Local Rules approved by the SPGA Committee.
- b) There will be no cut for this SPGA Golf Challenges 2018
- c) The winner of SPGA Golf Challenges 2018 shall be the player with the lowest gross aggregate score over the 54 holes.

6. Field Size

- a) SPGA Golf Challenges 2018 size of field will be limited to a maximum of **90** participants.

7. Draw

- a) The draw for the first and second rounds will be made by the SPGA Committee prior to the start of the SPGA Golf Challenges 2018 and will be posted on www.SINPGA.org.
- b) The Third (3rd) Round draw will be based on the cumulative gross scores of the preceding rounds.
- c) Players shall start at the time and in order indicated in the draw. No substitution of players and changing of starting times shall be permitted after the draw has been made unless authorized by the SPGA Committee

8. Prize Money

- a) The total purse for Professional & Senior Division is S\$30,000/-- Last prize is S\$ 300/-.
- b) Amateurs shall not be entitled to any prize money
- c) A levy of 10% on all winnings will be imposed and an additional of 15% will be withheld for taxation purpose for any professional who are not a citizen or permanent resident of Singapore.

9. Decision of Ties

- a) SPGA Golf Challenge Division - In the event of a tie or ties for the first place, the Winner shall be decided by a hole by hole play-off depend on the golf club, to take place as soon as practicable.
- b) In the event inclement weather or other reasons which make the play-off impracticable, the SPGA Committee's decision to determine the Winner is final.
- c) Senior and Amateur Division - In the event of a tie or ties for the first place, the winner will be decided on the lowest score for the last 18 holes (or the last 9 or 6 or 3 or 1 hole). If a tie still arises, the scores for the 2nd Round and, if necessary, the 1st Round will be treated in the same way until a decision is reached.

10. Entry Fee & Options

PARTICIPANTS (a, b, c, d)

- a) 3D2N (Twin sharing) including Entry fee for Professional and Senior : S\$500/- per pax.
- b) 3D2N (Single room) including Entry fee for Professional and Senior : S\$610/- per pax.
- c) 3D2N (Twin sharing) including Entry Fee for Amateur : S\$500/-per pax.
- d) 3D2N (Single room) including Entry Fee for Amateur : S\$610/-per pax.

Entry Fee above a), b) & c) includes:

- 3 Rounds Tournament Golf with optional of one practice round
- Transportation from Jetty to Hotel to Club and vice-versa
- Deluxe Room for 2 Nights at Palm Spring Resort w breakfast

NON-PARTICIPANTS (e, f, g, h)

- e) 3D2N (Twin sharing) Non- Golfer : **S\$300/- per pax**

There will be NO REFUND of entry fee after the closing date or any withdrawal notice unless medical reasons where participants must show proof of a valid MOH Medical Certificate to SPGA. Entry fee is not refundable. **All entries are to submit with the travel information form.**

11. Closing Date

- a) Entries must be submitted to SPGA, as stipulated in the Entry Form and payment, before 12.00 noon on 6th July 2018
- b) Incomplete entries, no payment, Late or verbal entries will not be accepted.

12. Suspension of Play for Dangerous Situation (Note to Rule 6-8b)

- a) The specimen Condition in the Rules of Golf is in effect – see page 140-141.
- b) All practice areas that are in the open shall be closed during suspension for a dangerous situation until the SPGA Committee has declared them open.
- c) A suspension of play for a dangerous situation and the resumption of play shall be signaled using the club's warning system.

13. Inclement Weather

- a) In the event that the first round of the SPGA Golf Challenge Division cannot be completed, it shall be continued the next day prior to the commencement of the second round.
- b) In the event that the second round of the SPGA Golf Challenge Division cannot be completed, it shall be continued the next day prior to the commencement of the third round.
- c) In the event that the third round of the SPGA Golf Challenge Division cannot be completed, the rounds shall be abandoned. The result of the SPGA Golf Challenge Division will then only be based on the completed minimum of two rounds.

14. Pace of Play

- a) Rule 6-7 (Undue Delay; Slow Play) will be enforced using the “Group Pace of Play” system.

15. Disputes or Doubt as To Procedures

- a) If there is a doubt as to the correct ruling, players are to refer to the Tournament Rules Official. If a Tournament Rules Official is not immediately available, a player (having notified his/her marker) may elect to play two balls in accordance with Rule 3-3 and obtain a ruling at the conclusion of the round, prior to signing and submission of the scorecard.

16. Tournament Rules Official / Referee

- a) The Tournament Rules Official/Referee’s decisions on all matters pertaining to the Rules of Golf are final.

17. Distance Measuring Device

- a) Measurement devices are permitted for this tournament **ONLY**.

18. Conditions of the Competition

- a) The specimen Condition in the Rules of Golf is in effect – see page 137 - 138.
- b) Acceptance of Conforming Balls & Driver Head, please refer to R & A website: www.randa.org
